

University Centre Hartpury's perspective on unconditional offers:

Our unconditional offer scheme allows us to support students in certain subject areas, who demonstrate passion, exceptional achievement, and academic performance. Our assessment will consider all indicators of potential. We will consider all that a student has to offer, including their experience and interests as well as the views of their current school or college. We will review the personal statement carefully and take into account the reference and predicted grades. We want to understand our students, and an unconditional offer will only be made if we are confident that it is in the best interests of the student, and will not adversely affect their current studies. To ensure this, we will have spoken with the student either face-to-face at one of our applicant days or on the phone, prior to any unconditional offer.

Our decision about whether to make an unconditional offer prior to examination results is influenced by many factors. The most important consideration is the best interest of our students. Although it is not always possible to offer an unconditional place, we would reassure students that this is not a reflection in our confidence that they will achieve, either in their current studies or when they come to Hartpury. When we make any offer, we make a commitment to our students. We consider anyone who has accepted an offer, whether conditional or unconditional, to be one of our students. We are confident they will achieve and they have our full support during their transition into Hartpury University and, naturally, when they are studying here.

Definitions of offer types:

Unconditional offer

This is an offer made by a provider where they are satisfied that an individual has demonstrated sufficient attainment and potential to succeed on their chosen programme. Based on the offer status at the 30 June application deadline.

Conditional unconditional offer

An offer made by a provider which was originally conditional, but becomes unconditional if the applicant selects that offer as their firm (first) choice. By definition, conditional unconditional offers that are selected as a firm choice by the applicant become unconditional and are also included in the unconditional offers group (see above).

Offer with an unconditional component

All offers showing as having an element of unconditional offer-making, that is, unconditional offers plus conditional unconditional offers that have not been selected as firm (and hence remain conditional unconditional).


All offers

All offers made by the provider, subject to the coverage of this report. This includes conditional as well as unconditional offers to 18-year-old main scheme applicants domiciled in England, Northern Ireland, and Wales.

Technical note:

The coverage of this report is limited to offers made by 30 June, to 18-year-old main scheme applicants domiciled in England, Northern Ireland, and Wales. This is because these applicants are least likely to apply already having achieved a full set of qualifications typically required for undergraduate higher education.
